RESOLUTION 2021-026

RESOLUTION REGARDING COMPLIANCE WITH U.S. CENTERS FOR DISEASE CONTROL AND WYOMING DEPARTMENT OF HEALTH COVID-19 RECOMMENDATIONS

WHEREAS, SARS-CoV-2 ("COVID-19") and its variants is a respiratory disease that spreads easily and sustainably between people who are in close contact with one anotheri;

WHEREAS, close contact includes living in the same household as a sick person with COVID-19; caring for a sick person with COVID-19; being within 6 feet of a person with COVID-19 for a cumulative 15 minutes or more over a 24-hour period; or being in direct contact with respiratory droplets from a sick person with COVID-19 (e.g., being coughed or sneezed on, kissing, sharing utensils)ⁱⁱ,ⁱⁱⁱ

WHEREAS, COVID-19 is transmitted by exposure to infectious respiratory fluids. This understanding is the basis of the recommendations for physical distancing, community use of well-fitting masks, adequate ventilation, avoidance of crowded indoor spaces, practicing good hand hygiene, and environmental cleaning;^{iv}

WHEREAS, the U.S. Centers for Disease Control ("CDC") recommends COVID-19 vaccinations for everyone 12 years of age and older for the prevention of COVID-19;^v

WHEREAS, the CDC recommends that anyone over the age of 2 who is not fully vaccinated wears a mask in indoor public places;^{vi}

WHEREAS, on July 28, 2021 the CDC published their *Interim Public Health Recommendations for Fully Vaccinated People* and recommend that all people wear masks in indoor public settings in areas of substantial or high transmission where physical distancing measures may be difficult to maintain; vii

WHEREAS, the Wyoming Department of Health ("WDH") publishes County Transmission Indicators^{viii} and as of August 11, 2021 WDH reported that Albany County was in the Orange Zone and classified as having moderate-high transmission levels; ix

WHEREAS, the Delta variant is currently the predominant strain in Wyoming, accounting for approximately 92% of new infections.* Delta is 200% more transmissible and results in 1,000 times higher viral load compared to previous variants. On average, one person infects 6-10 people, a transmission rate similar to chickenpox.

NOW THEREFORE THE BOARD OF COUNTY COMMISSIONERS OF ALBANY COUNTY, WYOMING, RESOLVES:

SECTION 1. That foregoing recitals are incorporated in and made part of this resolution by this reference.

SECTION 2. That within all buildings owned by Albany County and for all Albany County employees the most up to date CDC recommendations including, but not limited to, the use of masks for vaccinated and unvaccinated individuals, physical distancing, and protocols for close contact with someone with suspected or confirmed COVID-19 shall be complied with in their entirety.

SECTION 3. That where the CDC recommendations are based on local transmission rates, the WDH County Transmission Indicators for Albany County shall be used to assess Albany County's current transmission rates.

SECTION 4. That current requirements for use of masks within Albany County buildings shall be regularly updated and posted at each entry door.

SUPPORTING COVID-19 VACCINATION EFFORTS BY AUTHORIZING CONTRIBUTIONS UP TO \$25,000 FROM ALBANY COUNTY FUNDS FOR THE PROVISION OF VACCINATION INCENTIVES

WHEREAS, currently available vaccines are protective against the original virus and developed variants, leaving the unvaccinated at most risk. With increased community immunity an infectious disease is less likely to spread. There are people in the community who are unable to be vaccinated or unable to develop a good immune response to the vaccine. With community immunity reducing spread of the virus, a vulnerable person is protected by default. As rates of vaccinations go up, there can be an increase in indirect or community effects. Cases will start to ebb overall, but there will be some ups and downs;

WHEREAS, States with low vaccination rates have the highest transmission rates. As of July 6, 2021, 31.8% of Wyoming's population is fully vaccinated. Wyoming ranks 47th with only Arkansas, Mississippi and Alabama having lower vaccination rates. Currently, 43.4% of Albany County's population is fully vaccinated;

WHEREAS, on July 20, 2021 the Board of Commissioners of Albany County, Wyoming approved Resolution 2021-024 supporting the initiatives of Albany County Public Health and the City of Laramie to achieve a vaccination rate of at least 70%;

WHEREAS, a vaccine project working group consisting of members from the City of Laramie, Albany County, Albany County Public Health, University of Wyoming, Ivinson Memorial Hospital, the Downtown Clinic, and our community have been working on various initiatives including clinics at community events, transportation to vaccine sites and drawings to increase vaccination rates within Albany County; and

WHEREAS, to provide many of these initiatives support and funding from various governmental and non-profit agencies as well as private businesses is necessary to support vaccination incentives and efforts.

NOW THEREFORE THE BOARD OF COUNTY COMMISSIONERS OF ALBANY COUNTY, WYOMING, RESOLVES:
