**All Applications Must Include the Following:**

- Application:** Fill out the attached application form completely.
- Fees:** All applicable fees. Check or cash only, we do not process credit cards. Due with application.
- Letter of Consent:** Provide a letter of consent from all surface property owners on which the project will be located.
- Property Owners List:** Provide a certified list of property owners within 5 miles of the project boundary (See Page 4).
- Site Plan:** Please draft a site plan and include all of the following applicable items
  - Delineation of Project Boundaries
  - Solar Arrays
  - Primary Structures
  - Property Lines (identify all adjacent property owners)
  - Show setback lines
  - Public access roads and turnout locations
  - Substations
  - Electrical cabling from the solar array to the Substations' ancillary equipment
  - Transmission lines
  - Layout of all structures within the geographical boundaries of any applicable setbacks
  - Any other significant features or improvements, such as water, streams, irrigation ditches and fences
- Narrative:** Address the following impacts: Economic or Social Impacts, Air Quality, Water Quality, General Nuisances, Soil Disturbance, Wildlife Impacts, Cultural Resource Impacts – More information on these impacts can be found in Chapter 5 Section 12F(4)(f)(4).
- Proof of Ownership:** A copy of the deed, lease, or contract for deed as proof of ownership (This may be obtained from the Albany County Real Estate Office, located within the Courthouse).
- Proof of Legal Access:** Documentation that legal access exists.
- Reports:** Any reports, documents, or other information as required by the Albany County Commercial Wind Energy and Solar Energy Siting Regulations and Permitting (Albany County Zoning Resolution Chapter V, Section 12).
- Hard Copies of Application Materials:** Please provide 3 copies.
- Digital Copies of Application Materials:** Please provide a digital copy of all application materials.
